Overview
The Mental Health Services Act (MHSA) has funding for state-wide initiatives when multiple counties collaborate. The California Mental Health Services Authority Joint Exercise of Powers Agreement (JPA) provides the opportunity for the County of Sacramento to compete for state-wide funding.

Recommendation

1. Adopt the attached resolution stating intent to participate in the California Counties Mental Health Services Authority, a joint powers authority (JPA), with other California counties to develop and fund mental health services and education programs on a regional or statewide basis.
2. Authorize the Director of the Department of Behavioral Health Services or designees to sign the continuous agreement, act as a representative of the County of Sacramento in the JPA, and do everything necessary to assign funds.

Measures/Evaluation
This agreement supports the County's Strategic Objectives to minimize the impact of mental illness on individuals, families and the community, and will meet all requirements set forth by the State Department of Mental Health (DMH) regarding measures/evaluation.

Fiscal Impact
This action will not result in any net County cost. This action will increase access to compete for regional and state-wide Mental Health Services Act funding.

BACKGROUND

The Mental Health Services Act (MHSA) provides funding for mental health services to all 58 counties based on population. In addition, MHSA has funding available for regional or statewide

initiatives which require multi-county collaboration. The JPA was formed by a group of California counties creating a mechanism for strategic planning to optimize use of MHSA regional and state-wide initiative funding.

DISCUSSION

California Welfare and Institution Code allow counties to jointly administer mental health programs and services at their discretion. MHSA furthered this authority by including language that allow for "counties acting jointly" to administer MHSA programs. California Department of Mental Health (DMH) has set aside specific Prevention and Early Intervention (PEI) projects to be administered through a single entity. DMH has supported the development of a JPA for the administration of some of these projects. County Counsel has reviewed the JPA and had no adverse findings.

MEASURES/EVALUATION

This agreement supports the County's Strategic Objectives to minimize the impact of mental illness on individuals, families and the community.

FINANCIAL ANALYSIS

The PEI projects have been allocated a statewide total of \$40 million which counties cannot access individually. Participating in the JPA increases opportunities for securing funding as well as for strategic collaboration.

JOINT EXERCISE OF POWERS AGREEMENT

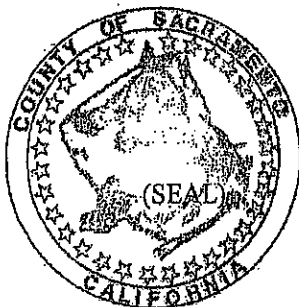
