80 Hour Training Provider Applications

- CalMHSA is opening our 80 Hour Training Provider Application Cycle from July 1- 31, 2025
- New applications will be for trainings in Spanish only
- Decision based on review of training capacity and access to culturally appropriate certification:
 - 1. English-language training is sufficient statewide.
 - 2. There's a continued need for more Spanish-language providers.
 - 3. Expanding Spanish-language options is a strategic priority.
- All submission materials will be required to be in Spanish (policies/curriculum)

80 Hour Training Provider Renewals

- 80 Hour Training Provider Application Cycle from July 1- 31, 2025
- Provider renewal applications will be accepted only during open cycle
- Must be submitted before contract expiration
- Follows the same requirements and process as initial application
- Exception: Curriculum changes require:
- Completion of the Training Curriculum Modification Request Template
- Notification to CalMHSA of any changes to previously approved curriculum


