### **No Cost Fee Waivers Update**

CalMHSA, in partnership with DHCS, offered time-limited fee waivers to support the behavioral health workforce. **All fee waivers have been issued in the following areas:**

- **Core Training (80-Hour Course) and Initial Certification**
- **Training in Areas of Specialization:** fee waivers for training in one or more areas of specialization.
- **Certification Renewals:** Fee waivers were made available

### **Student Next Steps Reminder:**

#### **80-Hour Core Training - Next Steps**

- **Register:** Students need to register on the CalMHSA Peer Certification Website
- **Application & Exam Fees:** No direct payment required from students. A prepaid code will automatically appear when prompted for payment of application and exam.
- **Schedule exam:** Our research shows that the sooner students take their exam after completing the course, the more likely they will pass the exam. We encourage students to schedule the exam right away.

#### **Specialization Training - Next Steps**

- **Certificate of Completion:** Get certification of completion from training agency.
- **Register Certification:** Students should log into their application at [www.capeercertification.org](http://www.capeercertification.org) and upload a copy of their specialization certificate to be recognized on the registry.

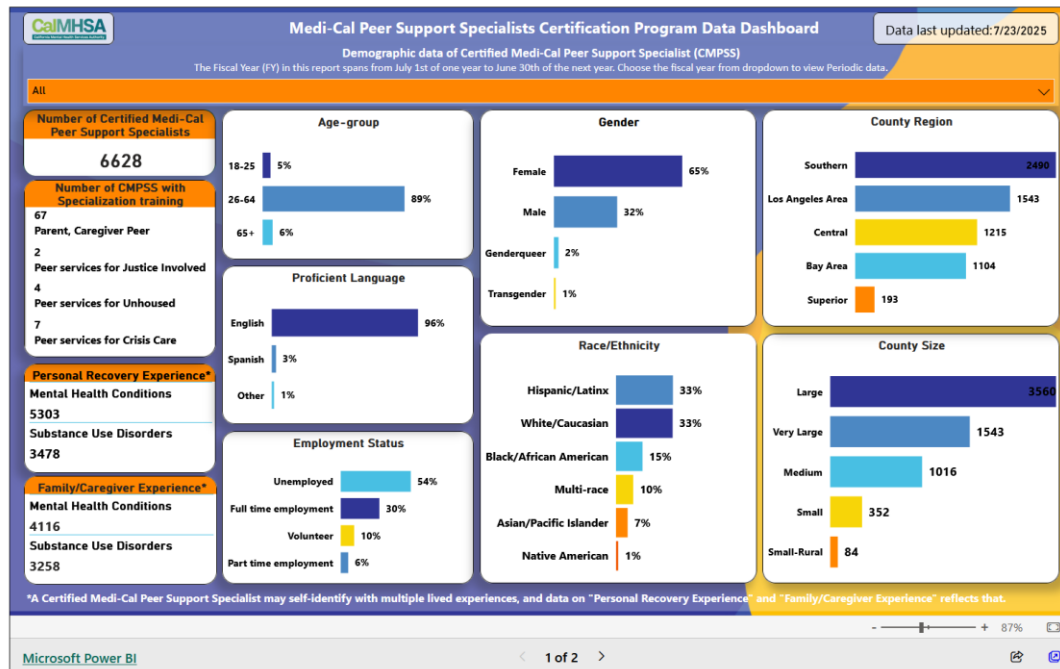
