Roll Call	We asked the Stakeholder Advisory Council members to type in their name and county in the Zoom chat to indicate their attendance.
Meeting Agreements	As a group, we reviewed the meeting agreements that have been previously established – no changes were made.
HumRRO Exam Process & Development: Tiffany C. Day	Tiffany discussed the exam development process. Tiffany also explained how the Job Task Analysis (JTA) information will be used to put together the Blueprint for the exam. Tiffany also discussed the Item Writing workshops and discussed the tentative timeline. The council members stated they took the JTA survey and the language that was used was too formal. Several Stakeholder members stated the language used in the peer field isn't formal. Stakeholders stated that the language level should be at a high school education level. Another council member stated that the JTA was too focused on case management functions, not the everyday functions of peer workers. The stakeholder stated that the exam should test field work functions, not case management functions, in order to

CaIMHSA Updates	California Mental Health Services Authority (CaIMHSA) has posted the JTA Survey on the CaIMHSA website, feel free to share the information with your networks. The Department of Health Care Services (DHCS) approved proposal is on posted on the website, in addition to, the Grandparenting checklist that was discussed at our previous meeting.
Scholarship Policy	A stakeholder asked if the scholarship would cover the exam training, in addition to, the exam cost. Another council member asked how many scholarships are allotted to each county. A council member asked to see the list of scholarships that was awarded to each county. A stakeholder stated that smaller counties will get less scholarships and the county will have to pay more out of pocket. A stakeholder asked what happens to scholarships that are unused in the counties.
Public Comment	The public stated the language on the exam should be simple, there will be other peers that have graduated in other countries that need to be able to understand simple language. The public stated that the exam should be general enough to address the needs and experience from all levels of peer support. The public stated that constant training in cultural competency and cultural humility in peer support work is important. The public asked if scholarships will be selected at random to allow fairness in the scholarship selection process.
